We wish to inform you that a subsidiary of PT Intiland Development ("Company") is considering to enter into a transaction with an affiliated party, as follows:

1.	Object and Value of Transaction	Signing of a memorandum of understanding to cooperate in operating a hotel at the Spazio Tower. Pursuant to the memorandum of understanding, both parties will set forth the points of cooperation into a more detailed cooperation agreement.
2.	Parties to the Transaction	PT Intiland Grande, a subsidiary of the Company that develops the Spazio Tower, and Artanti International Pte. Ltd., the brand owner-operator of the Kayumanis Hotel.
3.	Description of the Affiliation	Artanti International Pte. Ltd. is owned by Hendro S. Gondokusumo, the Company's President Director. The other party entering the transaction is the Company's subsidiary, thus the cooperation agreement between both parties is an affiliated transaction.
4.	Consideration to Enter Into the Transaction	The Company and its subsidiary is a developer in Indonesia that focuses on property development. Artanti International Pte. Ltd., a license holder of the Kayumanis Hotel, is a leading hotel operator in terms of guest management, tour

		and event planning, and hospitality management. With Kayumanis managing the hotel at the Spazio Tower, the hotel will have unique strengths not found in other hotel operators. This measure must be carried out in a prudent manner given the fierce competition in the hotel business in Surabaya. Kayumanis' strengths are key considerations for the Company's decision, after reviewing bids from two other hotel operators.

Additional Information	This Transaction: (i) is not a conflict of interest transaction for the Company as referred to in Regulation IX.E.1; and, (ii) is not a material transaction for the Company as referred to in Regulation of the Bapepam (Capital Market and Financial Institution Supervisory Agency) - LK No. IX.E.2 on Material Transaction and Change of Primary Business Sector.
